#### Discussion via Email-prior to meeting

**MOTION:** A motion was made by Howard Leslie, seconded by Kathy Michalski to cancel/postpone the Leadership Symposium and inform the 3 presenters and the hotel as soon as possible.

Discussion followed where the following points were made:

- Unfortunately, schools budgets are becoming tighter and people now have to choose what training events to attend. It is a shame that we may have to postpone/cancel this event, it is a great symposium. Agree that we should cancel/postpone the symposium before we incur any costs to the organization.
- Timing of when information about having the training was off- we submit our requests for professional development in the spring for the following school year, so monies had all been allocated long before we even knew this was a possibility. May be the case for many-timing and/or tight squeezes on the budget. Agree that it is a shame that we did not get enough

- registrants as the agenda looks great and know there has been a lot of hard work that has gone into the planning.
- Noticed in NASFAA news today that the Western association (WASFAA?) has this type of training
  in conjunction with their novice level training. It is too late to make similar arrangements for
  this year, but perhaps we could consider the combination of our novice and Leadership training
  for next year, and giving time to include budget requests for 2019.
- The cancellation should only be for the cost of the conference not for the 2018-2019 Membership that was included in the costs, correct?
- Funding to allow staff to attend has become more and more limited. I too feel sad that we have to cancel this event. I know a lot of hard work and time has been put into making this a great symposium.
- Think we have to give them the choice. Don't think it is right to keep the membership fees if the only reason they were becoming members was to attend the training. As much as we would love to have them as members, I think we have to give them the choice for a full refund or partial refund and they remain members.
- Sad that what would have been a wonderful event has to be canceled. Could we possibly have Novice and the Leadership Symposium at the same time? So we would essentially be offering a track for Novices and one for Leaders. Would intermediate folks want to spend 2-3 days in dorms? Or would we have them stay at a nearby hotel? Another thought considered was to have it at another time.
- Don't know if the option of a partial refund is in the hands of the administrators or would they
  run into flack from administration on how the school's money is spent? If our school paid for a
  training and it was cancelled they would expect a full refund of the amount paid, even if part of
  it was for a membership fee.
- As for tacking this conference onto Novice, would it be for every year or every other? Also
  would we need to expand staffing for volunteers to be able to run both trainings at the same
  time?
- Agree in that we should give them the option as to if they wish to have the full conference fee
  and membership returned or just the conference fee. It would be great to possibly tie it in with
  Novice training however not sure that it would happen this year but something to think about
  going forward.

**AMMENDMENT TO MOTION:** A motion was made to cancel/postpone the Leadership Symposium, and inform the 3 presenters and the hotel as soon as possible, and offer the Registrants the option of a full refund including membership fee (\$260.00) or just a symposium fee refund not including the \$40.00 membership fee (\$220.00). There was no further discussion. A vote was called-the motion passed with a quorum in favor of the motion.

### 2018-19 New York State Budget Highlights

Building on seven years of support for higher education, the recently approved 2018-19 New York State Budget invests \$1.2 billion for strategic programs to make college more affordable and encourage the best and brightest students to build their future in New York.

The following provides highlights from the 2018-19 State Budget pertaining to higher education.

### **Excelsior Scholarship Program**

For the 2018-19 academic year, the Excelsior Scholarship income eligibility threshold will increase, allowing New Yorkers with household incomes up to \$110,000 to be eligible. To continue this landmark program, the Budget includes \$118 million to support an estimated 27,000 students in the Excelsior program. Along with other sources of tuition assistance, including the generous New York State Tuition Assistance Program, the Excelsior Scholarship will allow approximately 53 percent of full-time SUNY and CUNY in-state students, or more than 210,000 New York residents, to attend college tuition-free when fully phased in.

### **Enhanced Tuition Awards Program**

The Budget includes \$22.9 million for the second phase of the Enhanced Tuition Awards program, providing up to \$6,000 in financial assistance including match funds and a tuition freeze to make college more affordable for residents attending private colleges in New York. For the 2018-19 academic year and thereafter, the program is modified to both serve students attending any in-state degree granting private college, and provide more flexibility in the matching requirement for colleges - including the exemption of colleges whose tuition rates are reduced by more than 15 percent from the rate charged six years prior, and permitting the use of existing institutional aid as the college match.

### **Appeals**

The 2018-19 State Budget newly permits the use of prior year income to establish income eligibility for the Excelsior Scholarship program in the event of the death, disability, divorce or separation of a household member whose income is used in determining program eligibility. Students whose current income or prior year adjusted gross income is \$110,000 or below due to these circumstances may appeal their disqualification by completing the Income Appeal Form and submitting it to Income.Appeals@hesc.ny.gov.

Students who are determined to be ineligible for failure to meet the annual credit or continuous enrollment requirements and who can demonstrate good cause may appeal the decision by completing and submitting the Excelsior Scholarship Program Appeal Form to Excelsior.Appeals@hesc.ny.gov.

## New York State Science, Technology, Engineering and Mathematics (STEM) Incentive Scholarship Program

The Budget provides \$4 million over four years to expand the STEM Incentive Scholarship Program to students attending a private, degree-granting college in New York State. Recipients will be selected by lottery, and will receive awards up to SUNY resident undergraduate tuition or actual tuition, whichever is less.

- Recipients with more than one STEM- approved major
- Students attending private colleges now eligible
- Updated enrollment requirements for final year of study

### **NYS Teacher Loan Forgiveness Program**

The 2018-19 Budget establishes the New York State Teacher Loan Forgiveness Program and commits \$1 million over four years to provide \$5,000 annual awards to teachers serving in high needs school districts or subject areas for which a shortage of teachers exists.

### **Excelsior Scholarship Program and Full-Time Attendance**

An Excelsior Scholarship recipient is deemed to be in full-time attendance if he or she is enrolled in at least 12 credits per semester and completes at least 30 combined credits per year (applicable to his/her program[s] of study) following the student's start date, or its equivalent.

As you are aware, students may use "banked" college credits that were earned while a high school student or in another nonmatriculated status to fulfill the annual 30-credit requirement. Students can also meet the full-time attendance requirement as follows:

### Students Enrolled in Fewer than 12 Credits Per Semester

The regulations governing the Excelsior Scholarship program authorizes that a recipient may use college credits earned while a high school student or while in another nonmatriculated status towards his/her enrollment in 12 credits per semester.

### Students Enrolled in Coursework Not Applicable Towards Their Program of Study

For a recipient who earned college credits toward his or her program(s) of study while in high school or while a nonmatriculated student and who is making satisfactory progress toward timely completion of his or her program(s) of study, and is enrolled in coursework not applicable toward his or her program(s) of study, such coursework outside of his or her program(s) of study shall be considered as contributing toward full-time attendance.

Consequently, when certifying your Excelsior Scholarship recipients, students who meet either of these conditions should be deemed to meet the definition of full-time attendance. The Excelsior Scholarship award amount should be calculated based on the 2016-17 annual tuition rate, but should not exceed the actual tuition charged.

### New York State Part-time Scholarship (PTS) Award Program

New York State Part-time Scholarship (PTS) Award Program provides scholarship awards to students who attend a SUNY or CUNY Community College part-time. Students can receive \$1,500 per semester for up to two years.

A recipient of the PTS Award Program is eligible to receive award payments for up to four consecutive semesters. Current students are eligible to receive an award. Students who are receiving a Part-time TAP award or Aid for Part-time Study (APTS) are eligible for this award.

### **Eligibility**

An applicant must:

- be a resident of NYS and have resided in NYS for 12 continuous months prior to the beginning of the term;
- be a U.S. citizen or eligible non-citizen;
- have graduated from high school in the United States, earned a high school equivalency diploma, or passed a federally approved "Ability to Benefit" test as defined by the Commissioner of the State Education Department;
- be matriculated in an approved undergraduate program at a SUNY or CUNY community college;
  - o (schools that offer two year programs are not eligible ie. Canton)
- be enrolled in at least six but less than 12 credits per term;
- maintain a cumulative grade point average of 2.0 or higher;
- be in a non-default status on a student loan made under any NYS or federal education loan program or repayment of any NYS award; and
- be in compliance with the terms of any service condition imposed by a NYS award.

### **Application:**

Students can apply for 2018-19 academic year.

The application opened on March 29, 2018 and closes on July 27, 2018.

# Guidance Regarding Full-Time Study for the NYS Science, Technology, Engineering and Mathematics (STEM) Incentive Program

# New York State Science, Technology, Engineering and Mathematics (STEM) Incentive Scholarship Program

The STEM Incentive Program regulations define successful completion of a term to mean, among other requirements, the completion of at least 12 credit hours or its equivalent in a course of study leading to an approved undergraduate degree in the field of science, technology, engineering, or mathematics.

### Recipients Enrolled in More than One STEM-Approved Major

To satisfy the full-time requirement, recipients who have enrolled in more than one STEM-approved major must successfully complete a combined total of 12 credit hours in their STEM-approved majors. Accordingly, students who complete 12 credit hours applicable to multiple STEM-approved majors should be certified as meeting the full-time eligibility requirements for the STEM Incentive Program.

Schools should take the necessary steps to certify any STEM recipient who was decertified for failure to enroll in 12 credits in his/her primary major since fall 2014.

### Recertifying Students Who were Decertified in 2014-15 or 2015-16

To recertify recipients who were decertified for either the 2014-15 or 2015-16 academic years:

- 1. Complete the STEM Recertification spreadsheet (HE9079).
- 2. Save the document using the acronym "STEM" and your school name; e.g., "STEMUAlbany.xls"
- 3. Upload the completed spreadsheet via the HESC secure file transfer process.

### Recertifying Students Who were Decertified in 2016-17 or 2017-18

If you are recertifying a recipient for the 2016-17 or the 2017-18 academic year, please use the standard process for submitting certifications (i.e., the HESC system).

### **Final Year of Study**

The requirement for a recipient to be enrolled in 12 credits applicable to his or her program(s) of study per semester is waived during the final year of study, as defined in the Commissioner's regulation.

A recipient is deemed to meet the full-time study requirement in his/her last semester if he/she takes at least one course needed to meet his/her graduation requirements and enrolls in at least 12 credits. Additionally, effective December 27, 2017, a recipient is deemed to meet the full-time study requirement in the semester prior to his/her last semester if he/she takes at least six credits needed to meet their graduation requirements and enrolls in at least 12 credits.

### Reminder: Get on Your Feet Loan Forgiveness Program

The NYS Get on Your Feet Loan Forgiveness Program provides up to 24 months of federal student loan debt relief to recent NYS college graduates who are participating in a federal income-driven repayment plan whose payments are generally capped at 10 percent of their discretionary income.

### Eligibility

### An applicant must:

- be a legal resident of NYS and have resided in NYS for 12 continuous months;
- be a U.S. citizen or eligible non-citizen;
- have graduated from a NYS high school or received a NYS high school equivalency diploma;
- have earned an undergraduate degree from a college or university located in NYS in or after December 2014;
- have earned no higher than a bachelor's degree at the time of application;
- apply for this program within two years of receiving an undergraduate degree.

- be enrolled in the federal Income Based Repayment plan at 10% of discretionary income, the Pay as You Earn plan, or the Revised Pay as You Earn plan;
- · have a primary work location in NYS, if employed;
- have an adjusted gross income of less than \$50,000;
- be current on all federal or NYS student loans;
- · be current on the repayment of any NYS award; and
- be in compliance with the terms of any service condition imposed by a NYS award.

The application is available now and we encourage schools to notify their recent graduates about this opportunity.
