Motion: A motion was made by Howard Leslie, seconded by Rob Zasso to make it a required responsibility of every manager of NYSFAAA such as chairs of regions, committee chairs or leader to update/inform the community on a regular basis of activities via the website.

A friendly amendment was proposed to add that it is the duty of the leaders to keep the membership informed and update the web with ongoing activities. This was accepted.

The Long Range Plan includes transparency and this speaks to that point

Another friendly amendment was added that the updates should occur after each meeting or event. This was accepted.

Revised Motion:

That NYSFAAA leadership including regional chairs and committee chairs have the duty to inform membership of activities and decisions by updating the website within a reasonable time after the meeting and/or event has occurred. These regular updates should be incorporated with the launch of the new NYSFAAA website.

INVESTMENT COMMITTEE

Purpose: The Investment Committee will serve as fiduciaries of the NYSFAAA investment accounts. The committee provides oversight of NYSFAAA's investment funds; coordinates regular review of the portfolios; shares relevant information with executive council and the membership on the health of our accounts; and makes recommendations to executive council regarding asset allocation and risk strategy.

Reports To: Treasurer

Duties:

- To perform an annual review of our reserve and scholarship funds in consultation with 1. our investment group.
- Convene a meeting (in person or remotely) annually to go over any updates and significant changes in our portfolios.
- To report to Executive Council pertinent investment information.
- To provide an annual report to the membership of the status of our investments.

Membership:

- The chair is an active member appointed by the President or Treasurer. 1.
- Additional committee members include the President and Treasurer; Treasurer-Elect or Past-Treasurer; at least two current members of executive council; and up to two additional members who may be active, associate or retired.

Tenure: All committee members are appointed to two year terms and are renewable.

Qualifications: All committee members should have an interest in providing fiscally responsible oversight of NYSFAAA's investments with deliberate effort towards serving and promoting the purposes of the Association outlined in our Constitution.

Motion: A motion was made by Kerry Lubold, seconded by Kathy Michalski to modify the proposed description of the Finance, Audit and Budget Committee by striking duty number 9 as it is not relevant.

There was no discussion. A vote was taken and the motion passed with all in favor, no oppositions and no abstentions.

FINANCE, AUDIT AND BUDGET COMMITTEE

Purpose: To serve in support of the Treasurer's accounting and recordkeeping functions, and to establish, present, review and recommend a fiscal year budget for NYSFAAA.

Reports To: Treasurer

Duties:

- 1. To submit the annual budget to Executive Council at the annual summer meeting for discussion, modification, and approval.
- 2. To submit the approved budget to the general membership at the Business meeting during the Annual Conference.
- 3. To review the budget on an on-going basis to determine if adjustments should be recommended to Executive Council.

4. To review the Budget requests of any Committees of members during the year for assisting Council in any fiscal action.

5. To request that each Committee (30 days prior to the summer meeting) submit their Budget Request Form to the Budget Committee in order to prepare the Annual Budget.

6. To meet prior to the start of next fiscal year (July 1), review all requests, and establish the preliminary budget for Council.

7. To notify the Committee Chairs of their budget after the June Council vote.

- 8. To review the annual audit.
- 9. To review investment strategy.

Membership:

1. Chair - An active member appointed by the President.

- 2. Three Active Members and no more than one Associate Member appointed by the Chair.
- 3. Three Council members, President Elect, President, and Immediate Past President.
- 4. Treasurer and Regional Treasurers ex-officio

Tenure: Chair – Two-year term coinciding with the terms of the statewide officers. Members – one year renewable.

Charter: Regional Thought Force on State/Regional/ National Alignment May 2016

Timeline & Commitment

Start Date:

October 2016

Max. End Date:

October 2019 (could end earlier dependent on work)

To ensure that high level strategic conversations and decisions are not lost due to volunteer turnover, consensus was reached by the regional presidents and NASFAA for a multi-year appointment. Each representative to this group should plan to serve for a minimum of three years. If deemed necessary, the composition of the group could change if the focus shifts to action planning and implementation.

Composition

Each of the six regional associations selects--through whatever means decided by their regional board--a group of three individuals, in addition to the 2016-17 Regional Observer to NASFAA's Board, to serve on a NASFAA-Regional Thought Force. Ideally, these individuals should be sitting regional board members. We strongly recommend that these individuals have experience volunteering at the state, regional, and preferably NASFAA-level, so they can bring a multilayered perspective to the discussions.

Background & Purpose

Over the course of several years, NASFAA has brought the incoming presidents of all six regional associations to DC to meet and discuss points of alignment, the role of the national association in supporting the regions and states, and the role states and regions play in the national context. The most recent meeting took place in September 2016; it was at that meeting that a need for a regional thought force was conceived.

One theme that has consistently come from these meetings is the idea that efforts are being duplicated at the state, regional and national levels, and in many cases each association is trying to "be all things for all people" rather than targeting/focusing on their specific strengths and value-adds. Another theme was the notion of turnover—in an all-volunteer organization with a new president at the helm each year, there is sometimes a lack of needed momentum to implement changes that require multi-year commitments.

This ongoing conversation, which has happened year after year, finally spurred the creation of a NASFAA Thought Force in spring 2016, chaired by RMASFAA Past President Art Young (Brigham Young University) and tasked with



thinking outside the box about this larger issue, highlighting the strengths, weaknesses, challenges and opportunities inherent to the national-regional-state association dynamic, and making recommendations for the next exploratory measures. At that meeting, representatives from each region reached consensus on several key strategic questions related to national and regional partnerships. No operational or strategic decisions were made at the state, regional, or national levels after the meeting. However, it was determined that the process of reaching consensus was important enough to expand the conversation to the current regional presidents.

During the September regional presidents meeting, it was suggested that we convene a larger group of regional, state, and national representatives to replicate that process again and see if we can reach consensus on multi-level strategic and/or operational alignments.

Task Force Duties & Responsibilities

- Engage in thoughtful, open, trusting, creative, and honest discussion on all issues related to national-regionalstate association alignments.
- "Think big" and not be constrained in discussions by the way things have always been done, e.g. status quo.
- By March 2017, produce a report detailing the findings from the larger convening, clearly indicating where the group had reached consensus. The paper should answer the following specific questions:
 - Should state, regional, and the national association share the same mission and goals?
 - Should a consistent portfolio of products, services and programs be offered nationwide?
 - Should associations at each level have complete freedom to determine their revenue streams and funding prospects?
 - o Should the state/regional/national associations rebrand and restructure into a collective organization?

If there is consensus on any single question or all questions, the work of the task force will be to develop plans to move towards those goals during the time remaining for the group. It is expected that another charter will be developed to guide their work.

Budget

The costs of the larger convening will be a cost share, with NASFAA covering the costs of lodging, food on-site, and a facilitator. Regions will cover all other travel costs.

HESC Update October 2016

2017-18 FAFSA & TAP Application

The 2017-18 FAFSA and TAP applications are now available.

The confirmation page of the FAFSA will provide a link for NYS students attending a NYS school to apply for TAP. The calculation for a TAP award will use prior prior tax information for processing (2015 tax information) for the 2017-18 year, the same tax data used to file the FAFSA.

All awards are subject to change based on the 2017 NYS Enacted budget.

2017-18 TAP Application Processing Changes

- Estimated awards will be available to students on HescPub and to schools on View Student Record beginning October 4, 2016. As in the past, a message will be displayed to indicate the awards shown are estimated until the State budget is passed.
- Emails will be sent to students beginning October 7, 2016 inviting them to log into their HESC accounts to see the status of their applications.
- TAP estimators will be available in early October. Students will now have the option to see the TAP estimates for a specific type of school or multiple types of schools.
- Student Status Listings will be sent to the schools in February, 2017, and will include the estimated TAP awards. The awards on the Student Status Listing will not be masked and will no longer include "Prelim" in the header on the file. Customized reports will be available in April 2017:
- Beginning with the 2017-18 academic year, students will no longer be able to report if they are enrolled in the EOP, HEOP, SEEK or College Discovery programs or in an approved five-year program. If a student is entitled to a fifth year of TAP awards, the information must be submitted by the school using Student Record Maintenance (SRM). The school must also confirm the enrollment for the fifth year of TAP payments through the certification process when the student is in the final two terms of studies.

The Veterans Tuition Award (VTA) will no longer include the college fee when determining the amount of the award. The VTA award will be limited to SUNY tuition only as set forth in section 669-a of the Education Law

NYS Science, Technology, Engineering and Mathematics (STEM) Incentive Program

The NYS Science, Technology, Engineering and Mathematics (STEM) Incentive Program application for the 2017 series is now available. The Program provides a full SUNY tuition scholarship to the top 10 percent of students in each NYS high school if they pursue a STEM degree in an associate's or bachelor's degree program and agree to live in NYS and work in a STEM field in NYS for five years after graduation.

To be eligible an applicant must:

- be a NYS resident and have resided in NYS for 12 continuous months prior to the beginning of the fall college term;
- be a U.S. citizen or eligible non-citizen;
- be a high school senior/recent high school graduate who will be enrolled full time at a SUNY or CUNY college, including community colleges and the statutory colleges at Cornell University and Alfred University, beginning in the fall term following his or her high school graduation;
- be ranked in the top 10 percent of his/her high school graduating class at a NYS high school;
- be matriculated in an approved undergraduate program leading to a degree in Science, Technology, Engineering or Mathematics at a SUNY or CUNY college;
- earn a cumulative grade point average (GPA) of 2.5 or higher each term after the first semester;
- execute a Service Contract agreeing to reside and work in the field of Science,
 Technology, Engineering or Mathematics in NYS for five years. View the terms and conditions of the service contract.

NYS Masters- in-Education Teacher Incentive Scholarship Program

Masters-in-Education Teacher Incentive Scholarship Program provides students who (a) have achieved academic excellence in their undergraduate studies, (b) are pursuing a master's degree program in education, and (c) agree to teach for five years in a classroom at a NYS public elementary or secondary school with a full tuition scholarship to a State University of New York (SUNY) or City University of New York (CUNY) college or university.

Award payments will be paid directly to the schools on behalf of students upon successful completion of each term. HESC will be issuing certification guidance shortly. Till then, HESC would like to share some frequently asked questions:

- Did HESC verify the UG degree was earned in NYS, or do schools have to?
 - HESC verified the UG degree was earned in NYS.
- Did HESC verify the 3.5 UG GPA requirement during the application process, or do schools have to?
 - The school would need to verify.
- Does the U. S. high school/GED/ATB requirement apply?
 - You would need to verify the high school requirement. This requirement applies to all HESC financial aid programs.
- Can certify based on these FTE classes?
 - For Masters in Education the school defines the number of credits required for full time study. For example, if full time is defined as nine credits then the MIE recipient would only be required to take nine credits to be certified for the award.
- If so, presumably we would report the number of credits and actual tuition and the award would be pro-rated somehow?
 - The school will not be required to report the number of credits the student is taking but will be required to report the actual tuition if it is different from the tuition reported on the roster
- What documentation, if any, would we have to make sure was available to justify the FTE? The Graduate Studies Office has a list of classes that are considered FT with less than 12 credits—is that sufficient?
 - o Yes

Homeschooled Students

To be eligible for State student financial aid, homeschooled students must meet the same criteria as students who attend public high schools: receive a high school diploma or the recognized equivalent, or a passing score on an approved ability-to-benefit test.

However, because homeschooled students do not receive a high school diploma that is acceptable for financial aid purposes – as only public and registered nonpublic schools in New York State are permitted by Education Law to award diplomas – they must demonstrate their eligibility for State student financial aid in one of the following ways:

 take and pass a Test Assessing Secondary Completion (TASC) formally known as a GED and receive a NYS High School Equivalency Diploma from the New

- York State Education Department (SED) by the first day of classes to be certified as eligible for a financial aid award for that term; or
- achieve a satisfactory score on an approved Ability-to-Benefit test by the term add/drop date.

On January 21, 2015, SED issued a memorandum providing additional guidance regarding high school equivalency requirements which indicated that a student without a valid high school diploma must hold a high school equivalency diploma or receive a passing score on a federally approved ability to benefit test.

High School Diploma

To be eligible for State student financial assistance, Education Law section 661(4) states that a student first receiving aid in academic year 1996-97 to 2006-2007 must have a certificate of graduation from a school providing secondary education, or the recognized equivalent of such certificate, or receive a passing score on an approved ability-to-benefit test. For students first receiving aid in academic year 2006-07 and thereafter, the certificate of graduation must be from a recognized school providing secondary education within the United States; or the recognized equivalent of such certificate; or received a passing score on a federally approved ability to benefit test that has been identified by the board of regents and has been independently administered and evaluated as defined by the commissioner.

Therefore, a student without a valid high school diploma must hold a high school equivalency diploma. A student can earn a high school equivalency diploma in New York State in one of three ways: (1) by taking and earning passing scores on a TASC test or (2) by completing 24 semester hour credits in specified subjects as a recognized candidate for a degree in an approved (accredited) institution or (3) through the National External Diploma Program. Note:

1. The New York State High School Equivalency diploma may also be awarded to those candidates who meet all New York State requirements and who submit an official report of results from a GED® Test taken outside New York State prior to 2014. Candidates will receive a diploma and an official transcript certifying that

- they were awarded the New York State High School Equivalency diploma based on GED® testing out of state.
- 2. For financial aid purposes a record of a prior degree earned by a student is not acceptable.

FFEL Access on HESC System

Due to increased security requirements by the US Department of Education, school access of FFEL data will be removed from the HESC website. HESC staff will be able to view the accounts if any questions arise. The change is expected in January 2017.
