President's Report – Darrin Rooker

EASFAAA

- o Reported last EASFAAA meeting in the June EC meeting
- o Next meeting is Sept. 30th Oct. 2nd in Albany, NY-Albany Hilton
- Confirmed institutional bylaw change did pass
- HESC board meeting
 - Meeting held August 1st

- Board is more diverse when it comes to the major school sectors now being represented on the board compared to prior years.
- President of HESC report-started by playing a video of HESC and what it does as an agency. He then talked about how HESC administers 27 individual NY State financial aid programs.
- HESC wants to utilize more technology in the future. Possibly a State student aid app. for students to use when applying for aid, like the FAFSA app.
- Regulations were passed to clean up some of the language in previous regulations, and open up the definitions of "eligible" schools for the Enhanced Tuition Assistance program; in order to be inline with the new statutory language expanding the program.
- o Leadership council members made their statements at the end of the meeting
 - Darrin made NYSFAAA's statement
 - He focused on NYSFAAA's Novice program and importance of HESC being a part of it, and thanking them for their support.
 - He strongly stressed the need for a comprehensive policy & procedure manual for the Excelsior and ETA programs, and stressed how vulnerable financial aid administrators feel right now while they are trying to administer these programs.
 - SUNYFAP made their statement demanding comprehensive guidance on the administration of the Excelsior program.
- Darrin stated he will continue to keep Council up to date as issues develop with the new State aid programs.
- O Darrin stated that he is getting telephone calls from reporters concerning SUNYFAP's and NYSFAAA's comments made at the August 1st HESC board meeting. Darrin was quoted in Schenectady's "The Daily Gazette" newspaper on his remarks made at the HESC board meeting.
