

At this point, there is not enough information given from the bank to know who the payment is coming from.

- Continue to actively monitor proposed and passed NYS and Federal financial aid and higher education legislation (including Reauthorization proposals), with the goal of preparing possible comments, feedback, and where appropriate letters of support/endorsement of such legislation for approval and dissemination by the Executive Council and NYSFAAA President respectively.
- Organize and lead NYSFAAA's participation in the 2023 Student Aid Alliance Advocacy Program, which will likely consist of virtual advocacy efforts. Review NYSFAAA's State Aid proposals and make appropriate changes and/or updates.
- Encourage & support members from each Region of NYSFAAA as well as members of the Government Relations Committee to participate in advocacy with their local elected officials – continuing to raise awareness of NYSFAAA online resources, the Association's community outreach efforts (i.e. FAFSA & TAP Webinar), and to promote support for NYSFAAA's State Aid Proposals.

## **2021 Conference Report**

2021 has been an unprecedented year given the ongoing COVID 19 pandemic.

In November 2020, Executive Council (EC) decided to move the annual conference to a virtual format once again. We continue to work with Hilton Long Island to facilitate use of the deposits that were initially made for the anticipated ECmeeting in June 2020 and the planned 2020 conference. It is hoped that NYSFAAA will be able to use those funds sometime in the future for training, EC meetings etc.

The 2021 conference took place virtually over 3 days - October 26 - 28, 2021 The conference fee was \$50 for all paid members. 2021 Novice attendees were granted a free conference registration. The final number of registrants was 49Novice, 352 paid, total 402.

#### **Business Partners**

#### Chairs – Chris Earnshaw and Stephanie Stock

As this was not an in-person but rather a virtual conference, opportunities for business partners (BP) were limited. We explored the possibility of purchasing the exhibitor add-on within the Whova platform, but it was determined that due to lack of interest from attendees (indicated in the survey responses after the 2020 virtual conference) and overall costthat this was not feasible. As an alternative, business partners were asked to submit a donation to the George Chin Memorial Scholarship (GCMS) Fund. This scholarship program aids high-performing students of need attending schoolsthroughout New York. In exchange for their donation, NYSFAAA posted the business partner's company logo and link on the Whova platform, increasing exposure for that business partner. Business partners were solicited several times over the preceding months leading up to the virtual conference. In all, requests were sent to 41 business partners and 14 business partners were able to contribute, resulting in \$4,400 in donations to the fund.

## **Publicity**

Stephanie Stock, Debbie Evans and Jeanne McCarthy developed a cadence of emails that were sent every two weeks viamember clicks communication center that included both information on registration and fundraising for the GCMS. These communications were sent by the webmaster.

Recommendations (when back to in-person conferences)

- Engage social media
- Create videos to promote key sessions and pre-conference workshops
- As the conference is approaching, send at least one email per week.
- Access should be given to the Publicity chair to allow them to be able to format the emails in MemberClicks suchthat it is possible to change font size, color, and general formatting (e.g., bullet points, anchor text for links, addition of photos, addition of other visuals etc.)
- Coordinate any email messaging that is going out to the general listserv with the various conference subcommittee chairs so that timing of messages makes sense and there isn't a deluge of emails with competing messages.
- We strongly recommend checking with non-conference committees to ensure they are not
  planning communications on the same day we received complaints about too many NYSFAAA
  emails.



#### **Technology**

Chairs – Howard Leslie and Sean Sherwood

The technology used for the NYSFAAA 2021 Conference was two-fold:

- 1. WHOVA Whova is a conference agenda/engagement platform that allows conference organizers to build and manage their conference details, attendees, agendas, presentations, etc. as a "one stop shop." The NYSFAAA Conference Committee utilized WHOVA to post the 3-day agenda and manage the many ZOOM links which were assigned to the various sessions. WHOVA also allows the organizers to load in registered attendees, communicate withattendees, and provide interactive engagement within the platform, including an open forum, photo posting, and messaging functions.
- 2. ZOOM Zoom was used for the actual presentations. We used both the ZOOM Webinar feature (for the large sessions 1000-person capacity) and the ZOOM Meeting feature (for the breakout sessions 100-person capacity). Eachbreakout session was assigned a different ZOOM room "link" which was managed by a moderator and speaker for each session. The rooms were linked in each agenda session and on the main landing page in WHOVA.

It was decided by EC that each session would be recorded and made available to only registered conferees. This was announced when the conference began. This ended up being a good decision due to the technical difficulties during the first session which prevented recordings. No one can say they registered based on the promise of recordings.

Our zoom license promised 20 Giga Bytes (GB) of cloud memory. Not knowing how much memory we would require weincreased our cloud memory by 100 GB for October. We ended up only using 14 GB.

The Technology and Innovation Committee decided to let the recordings continue to be housed on the cloud rather thantransfer them to YouTube. The advantages of that were the ability to post the videos to the website quickly at the end of each day, and the view is far more professional. The disadvantages are if storage space may be needed next year, we willhave to remove the videos from the website or add/pay for more space or transfer to YouTube and we will lose the ability to count views (until it can be figured out (if at all)).

All in all, we are pleased that we decided to record the sessions. It seems to be very popular.

#### **Fundraising for the NYSFAAA GCMS**

Chairs - Crystal Krudis and Janice Hilbrink

Being in a virtual environment for the 2<sup>nd</sup> year in a row, the NYSFAAA website was enhanced to allow individuals to makedonations to the GCMS. It was again suggested to the membership that if a member passed away, a donation could be made in their memory, which would aid in the effort of NYSFAAA's goal of providing support to students attending schools in New York State. This appears to have been well received by the membership as there were donations made, totaling \$785. (An additional donation from the Chin family is pending).

Since there was no "vendor" area where our BP have traditionally paid to have a space where they could meet with members, a recommendation was made to solicit donations to the GCMS (which is allowable under the SLATE Act). The donation allowed the corporations to provide a logo with a link to their company's website which were displayed both before and during the conference on the Whova app. **14** business partners contributed



resulting in \$4,400 in donations to the fund.

For members to participate in the fundraising process as they would at an in-person conference, the committee proposed virtual and 50/50 raffles. Each region was asked to provide e gift cards for prizes. These prizes ranged from

\$100 to \$250. Tickets were sold through the website with all purchases made by credit card with the funds going directly into the scholarship account. There were 184 participants in the raffles with income totaling \$1,805. The virtual 50/50 was handled in the same way. There were 177 participants with income totaling \$1,560 with \$780 going to the winner and \$780 going to the scholarship fund.

The total income for the 2021 going to the NYSFAAA GCMS was \$7,770. This amount fully covered the cost of the 5scholarships awarded this year at \$1,500 each.

# **Treasurer; Budget and Investment Committee**

#### Summary of Activities for 2021-2022:

COVID has continued to create an interesting situation for our organization financially. This year's budget creation included conversation and projections moving back to in person meetings and conference, knowing that many schools are still operating under limited budgets. Determining estimated participation at conferences is challenging as we do not have historical data of what our association looks like coming out of a pandemic. Prices of consumer goods and services have also changed significantly since our last in person events, which further complicates the ability to accurately forecast numbers and create an effective budget. Our expenses over the past year have been significantly less with online activities, conferences and training. Overall, our accounts continue to be in good health.



The Treasurer coordinated with committee chairs, executive council leadership and others as appropriate to develop the 2022- 2023 Budget. At that time, the Treasurer was also able to provide current information on the overall financial condition and cash flow status of the organization and to review current NYSFAAA investments. Robert Bell from Morgan Stanley has handled our investment accounts for a very long time, and we are grateful for the guidance he provides. At our August Executive Council meeting, our auditors joined us to share the 2021 year-end reports and financial statements and answer questions. We are fully up to date with audits and anticipate starting and completing the 21-22 audit this fall.

All payments for membership, scholarship donations, and other paid trainings continue to be processed directly by the treasurer. In the past, membership and scholarship donations were processed by the committee chairs. This changed when NYSFAAA transitioned to MemberClicks. This is a significant change in the amount of time it takes the Treasurer to ensure timely recording of payments and accurate financial records. The return of NOVICE and the addition of the Student Loan Bootcamp Training also increase the activity of the treasurer and income coming into the organization. The President, President Elect, Treasurer, and Treasurer elect have been meeting to discuss the time commitment needed by the Treasurer and have been discussing possible solutions in addition to discussing how we can create more checks and balances and separation of duties.

#### Goals and Objectives for 2022-2023:

The primary short term goal is transition Treasurer Elect into the Treasurer position with the assistance of the Treasurer who transitions to Past Treasurer. Access to accounts and training have been ongoing over the last few months.

Discussion has been ongoing in regard to the utilization of a drop box with KeyBank where our accounts are held. We are hoping to conclude the cost analysis and visit the Albany location where the drop box would be located to learn more about what our process would look like.

Finally, requests from our members for an option for electronic payment (ACH/direct deposit) continue to come in. Additional research on how to handle these types of payments needs to happen. At this point, there is not enough information given from the bank to know who the payment is coming from.

- For the Fall 2021 NYSFAAA Regional Training meeting on November 19, 2021, the GRC Co-Chair, Christopher Barto, co-presented another joint NYSFAAA/NASFAA session entitled: "Financial Aid Advocacy and You 2.0: Getting started and where to go from there!"

- On Feb. 8, 2022 the GRC Co-Chairs attended a Region 7 meeting and presented on "The Benefits of Advocacy & How to Effectively Engage with Local Legislators" to encourage and offer to support regional advocacy efforts with key local elected officials.
- In early April 2022 the GRC provided detailed feedback on proposed NYS Senate Bill S.5136B per a request from the Charles Silverstein of the Senate Minority Conference. The bill was introduced by Senator Kevin Thomas and contained language that would have significantly expanded the definition of what is considered a private education loan in NY, in particular treating many institutional payment plans as such. The GRC outlined our concerns and several technical considerations and the EC voted unanimously to approve the recommended feedback.
- Throughout spring 2022 the GRC reviewed the text of several other proposed (pending & passed) NYS higher education bills, paying particular attention to the following:
  - 1. S5924C/A6938B "Transcript Bill" sponsored by Sen. Thomas signed by Gov.
  - 2. S7699 Prohibits institutions from implementing any contingencies (i.e. mandatory arbitration agreements, etc.) upon receipt of state funding sponsored by Sen. Stavisky signed by. Gov
  - 3. S8484 "Fair College Admissions Act" would prohibit Legacy and Early Admissions policies at NYS colleges sponsored by Sen. Gounardes pending in Higher Ed Committee
- Continued participation in quarterly NYSFAAA meetings with HESC VP Elsa Magee to assist with communication & collaborations.
- GRC Co-Chair, Christopher Barto, in late fall 2021 was invited to join a newly forming NASFAA State
  Advocacy Network (with representatives from each state association). The group officially launched in
  August 2022 with a Charter and the GRC Co-Chair attended the Kick-Off meeting on September 13, 2022.
  Meetings will be held virtually bi-monthly. The group's charter outlines the following overarching purpose &
  goals for this new NASFAA initiative:
  - 1. "Using the advocacy toolkit as the foundation for its state-level work, NASFAA will rely on the State Advocacy Network to spread awareness of this resource among states, provide a forum for leaders in state student aid policy, and monitor additional ways in which NASFAA might support state-level advocacy efforts. Although each state's financial aid system is unique, even states with drastically different student aid landscapes may experience similar policy proposals within their state legislatures. Establishing a network of leaders who are active in monitoring state legislation will help states to be cognizant of emerging issues that may appear in their own state, and to learn best practices that have been effective in other states' advocacy efforts. The network will also allow for NASFAA to gain feedback on additional resources that would be helpful to state-level advocacy efforts and will establish strong communication channels through which states can request additional support from NASFAA on state issues."

## Summary of Activities for 2021-2022:

The 2022 Novice training was conducted virtually via the Whova platform from June 13<sup>th</sup> through June 17<sup>th</sup>, 2022. We had 118 participants that completed the training and earned their completion certificate.

Despite being virtual, the format of the training was similar to the in-person event. Participants were broken into seven (7) TV-show themed small groups (15-17 participants per). The Committee worked very hard to foster networking and interaction amongst the participants. Some interesting statistics from the Whova platform include:


