#### advocacy

the act or process of supporting a cause or proposal; the act or process of advocating something

#### advocate


a person who argues for or supports a cause or policy





#### First Amendment Roots

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances"



#### Why does advocacy matter?

With Congress consistently caught in gridlock, it's more important than ever to make sure your voice is heard in policy debates – especially on issues that could affect you on a daily basis Members of Congress and their staff are most interested in the day-to-day concerns of their constituents in their states and districts

Your voice matters!


#### **Advocacy Basics**



# NASFAA's Core Advocacy Principles

We believe that the purpose of student financial aid is to ensure everyone has equal access to postsecondary education. NASFAA adheres to the following core principles, originally created by the NASFAA Reauthorization Taskforce and updated during the National Conversation Initiative to reflect our current goals for college access and success. NASFAA affirms that student financial aid should:

- Promote fairness and equity for students across all sectors of postsecondary education, with a particular emphasis on low-income, underrepresented and underserved students;
- Stress the primacy of need-based aid;
- Support policies that address the needs of disadvantaged students;
- Advocate accountability;
- Encourage simplicity and predictability;
- Empower student financial aid professionals and their schools with the flexibility to respond to the specific needs of their students;
- Recommend policies that accommodate the diversity of academic delivery models;
- Encourage the use of technology wherever possible;
- Eliminate statutory requirements that use financial aid to enforce unrelated social policies; and
- Validate proposed recommendations with research and data analysis wherever possible.



#### **Advocacy Principles in Action**

#### Our advocacy efforts center around these major policy areas:

- Increasing access to higher education, including early awareness and outreach
- Simplifying student aid systems
- Encouraging college persistence & completion
- Promoting college savings and financial education
- Minimizing student indebtedness and emphasizing grant and work aid
- Supporting the primacy of need-based aid








## **Being an Effective Advocate**

**Congressional Offices:** Which of the following advocacy strategies should constituents **do more of** to build relationships with you?



**Congressional Offices:** How helpful is it for constituents to communicate the following? How frequently do constituents communicate the following?






Congressional offices report that their constituent interactions are both more numerous and more substantive than before the pandemic.








# **Congressional Advocacy During COVID-19**



# Getting Started in State Advocacy







#### **Getting Started**

- 1. Decide which issues your advocacy will focus around  $\rightarrow$  Core Advocacy Principles.
- 2. Identify key advocacy audience(s).
- 3. Develop relationships with other state-level stakeholders engaged on similar issues.
- 4. Identify existing resources (from NYSFAAA, NASFAA, etc.) that can be used to develop message and key talking points.
- 5. Engage colleagues & students in advocacy initiatives.





#### **NASFAA's State Advocacy**

#### Develop "Core Advocacy Principles"

- Questions to consider?
  - What is the mission of your organization
  - What is important to your association?

  - What do you believe in?
    What major issues keep coming up at the state level?
- Tips:
  - Narrow your focus—too many principles dilutes what is truly important (4-5 is optimal)
  - Don't get so specific that you box yourself in, but be broad enough that one principle could capture multiple issues



#### NYSFAAA's Advocacy is Based on Member Feedback

NYSFAAA's Student Aid Membership Surveys in Dec. 2019 and Dec. 2018 have helped inform NYSFAAA's legislative priorities and the GRC's Advocacy Efforts.

- 2018 Survey 75 Respondents
  - 91% Supported Inflation-Based TAP Increases
- 2019 Survey 159 Respondents
  - 88% Supported Advocating for a Single Streamlined State Aid Application
  - 73% Supported Advocating for one TAP Award Schedule and Maximum Eligibility for all students regardless of Dependency Status

# NYSFAAA's Student Aid Advocacy Agenda for 2021 & Beyond

#### <u>Advocacy Principle #1</u>: Support Meaningful TAP Awards for New York State Students

- We recommend phasing in over three years (to 2024):
  - An increase in the maximum Tuition Assistance Program (TAP) Award from the current maximum of \$5,165 to \$6,000
  - An increase in the minimum TAP award to \$1,000 (from \$500)
  - An increase in the TAP income eligibility from \$80,000 to \$110,000 NYS Net Taxable Income (NTI).





# NYSFAAA's Student Aid Advocacy Agenda for 2021 & Beyond

# <u>Advocacy Principle #2:</u> Support Opportunity Programs Serving Our Most Vulnerable Students

- To support access and effective programming, we urge an across-the-board 20 percent increase for all Opportunity Programs:
  - Educational Opportunity Program (EOP), College Discovery Program, Search for Education, Elevation, and Knowledge (SEEK) Program, the Collegiate Science and Technology Entry Program (CSTEP), its high school counterpart STEP, and the Liberty Partnerships Program (LPP).
  - For the Arthur O. Eve Higher Education Opportunity Program (HEOP), we request a 20 percent increase per FTE.





# NYSFAAA's Student Aid Advocacy Agenda for 2021 & Beyond

#### Advocacy Principle #3: Eliminate Dependent vs Independent Student Disparity in Access to TAP Awards

- Use the same TAP Award Schedule, income, and maximum award eligibility for all students regardless of their Dependency Status.
  - Independent students who are married or single <u>and have no tax dependents</u> receive significantly lower TAP awards compared to dependent students and independent students with tax dependents (with a maximum award of \$3,025 compared to \$5,165 for the later group).
  - TAP eligibility for independent married students without dependents is limited to those below \$40,000 NYS Net Taxable Income (NTI) while eligibility for single independent students without dependents is restricted to those with NTIs no higher than \$10,000.





# NYSFAAA's Student Aid Advocacy Agenda for 2021 & Beyond

<u>Advocacy Principle #4</u>: Align NY State to Federal Use of Professional Judgment (PJ)

- As Financial Aid Administrators (FAAs) we are allowed to exercise "Professional Judgment" for Federal Title IV programs for defined, well-documented extenuating circumstances, allowing adjustment of aid awards to better reflect significant changes in family circumstances or a student's and/or family's ability to pay based on losses to family income.
- We urge the state to allow FAAs to exercise Professional Judgment for state aid programs. This would give FAAs the authority to consider granting independent status (i.e. "Dependency Overrides"), or to revise household income and certain other data elements with appropriate documentation.





# NYSFAAA's Student Aid Advocacy Agenda for 2021 & Beyond

#### Advocacy Principle #5: Address Higher Education's COVID-19 Related Budget Issues

- Restore Bundy Aid Funding:
  - We urge the legislature to fully restore Bundy Aid in the FY 2022 Budget and reject cuts to Bundy Aid funding that the Legislature already approved in the FY 2021 budget.
- Confirm State Aid eligibility waivers for COVID-19-Impacted Students:
  - Waiting for One-Budget to finalize that school certified COVID-19 impacted students will not lose their next TAP payment(s) due to SAP (Satisfactory Academic Progress) or POP (Pursuit of Program) issues and/or due to withdrawal from their classes.
- Understanding Impact of 20% Delayed Withholdings





## NYSFAAA's 2021 Advocacy Efforts

- NYSFAAA has been involved with the annual NY Student Aid Alliance Advocacy Days, sponsored by CICU, for many years
- Advocacy Focused on Connecting with Key Committee Leaders in the Legislature
  - On Feb. 10, 2021 GRC & EC members met with:
    - » Senator **Toby Ann Stavisky's** Office Chair, Senate Higher Education Committee (Reintroduced S2764 & S2765 – To eliminate old TAP Award Schedules)
    - » Assembly Member **Deborah Glick's** Office Chair, Assembly Higher Education Committee
    - » Senator Liz Krueger's Office Chair, Senate Finance Committee
- Strengthening NYSFAAA's Relationship with HESC and the State Education Department (SED)
  - Established quarterly NYSFAAA meetings with **Elsa Magee**, Executive VP, HESC
  - Several GRC & EC members serve on the Inter-Agency TAP Regulations Workgroup, Chaired by Dr. Chris Fernando, Supervisor of Higher Education Programs, SED





#### NYSFAAA's Federal Advocacy

- In July 2021 NYSFAAA Endorsed NASFAA's policy recommendations from the November 2020 publication "<u>Investing In Our Future</u>: Top 5 Student Aid Policies Needed to Sustain and Strengthen Higher Education":
  - 1. Deliver additional COVID-19 Relief to Students and Institutions
  - 2. Strengthen the Federal Pell Grant Program Double the Maximum Pell Grant
  - 3. Simplify the Federal Financial Aid Application Process
  - 4. Curb Student Indebtedness and Simplify Repayment
  - 5. Enhance Student Aid Delivery
- The NYSFAAA GRC also actively encouraged all NYSFAAA members to join the campaign to Double Pell
