Rates that Add to Debt (POST GRAD) Act" with the addition of the Graduate PLUS loan program language as follows:

Today's employment market demands many more positions be filled by individuals holding advanced graduate and first professional degrees. Students pursuing these advanced degrees have very limited funding options other than student loans. Currently, the federal student loan programs available are the Direct Unsubsidized Loan Program and the Graduate PLUS Loan Program, both of which accrue interest while the student is still attending school. This interest accrual costs individual students' tens of thousands of dollars in additional interest and payments over the repayment period of the loan.

Discussion followed where the following points were made:

Lea Newer recommended adding information on Grad PLUS since that program is another funding option for Grad students and include information about the terms and conditions (i.e. higher interest and origination fee rates)that would help to drive home the points already made in the letter.

EASFAA -Fall Meeting

Adrienne King and Howard Leslie attended the EASFAA Fall Meeting in Baltimore, the venue for the Spring conference to be held from May 15 to May 18, 2022 at the Baltimore Inner Harbor Hilton. The Conference fee will be reduced to \$460.

The 2023 Conference will be held in in Manchester, N.H.

EASFAA recently canceled their social media contract as part of their move back to in person meetings.

A call for presentations will be going out to membership for the upcoming conference.

The EASFAA President-Elect is looking to update the Policy and Procedures and Technology Committee. As part of the Policy and Procedures update, EASFAA is looking to use the relaxed version of Roberts rules

EASFAA also is likely to continue NASFAA Credential training. Other state organizations will be continuing with this training NYSFAAA will not be joining in this initiative. Many state organizations are still concerned with COVID related issues.

First Vice President's Report

Swift

Renee Swift provided the following report

Membership

Update on membership: 1056 active members per the MemberClicks dashboard; per the EC minutes from October 2020, there were 783 active members. Discovered a small glitch with regard to members being able to subscribe to their regional listserv. An email went out to the membership asking them to look at their profile to confirm enrollment in the statewide listserv and their regional listserv (if they want to opt in). Members were referred to Howard and Lea for assistance.

Membership committee met on September 23. Only two member reps attended. We did discuss plans to review and update the membership application for the 2022-23 cycle. In addition, I sent out lists of lapsed members to each regional rep for them to review the lists. Plan is to remove those that have been confirmed as "out of the business" from receiving future communications. Also emailed the regional chairs their respective lists of members who attended Novice training so that regular communication and engagement can continue with our newest financial aid professionals.

• Mentorship Committee

Renee recognized Taylor Kruetter as a committee of one as the remaining member of the committee stepped down due to lack of activity. It is believed that the Novice Conference will be the best option for connecting with individuals. Taylor plans to ask someone to step in as chair of this committee as she is joining the Executive Council as Treasure-Elect.

TICC has been tasked with increasing NYSFAAA's social media presence. To determine the best method to do so, a sub-committee was formed to analyze the feedback from a recent social media related membership poll and research on industry best-practice. Based on available information and current resources, the TICC sub-committee recommends focusing and building NYSFAAA's Facebook presence through the use of regularly scheduled posts on their public page and implementing a private members-only group.

• Platforms and Audience

- In August 2021, TICC distributed a membership survey to gauge interest in expanding NYSFAAA'ssocial media presence. The majority of respondents (68%) use Facebook regularly. We recommend focusing our increased social-media presence on Facebook to meet members where they are and to expand to other platforms once we're successful on Facebook.
- Furthermore, national data shows a majority of people between the ages of 18-65 use
 Facebookwhich further proves it to be a compelling platform for engaging individuals most likely interested in NYSFAAA (https://khoros.com/resources/social-media-demographics-guide).
- The sub-committee recommends we increase the number of announcements shared through our Facebook post. Based on national best-practices, social media marketing for associations is an essential part of digital marketing to boost membership engagement. The rule of thirds is recommended: one third of posts should promote member benefits, one third should be interacting with members, and one third should be sharing industry news, tips, and informative content our members would benefit from. NYSFAAA's social media content should be focused on our membership with the majority of posts applicable to financial aid administrators and the rest focused on interests of our associate members, including but not limited to vendors and other college-access colleagues. Although non-members (ex: students' parents, etc.) may follow our public page, content will be geared toward members. Members may then engage students directly versus NYSFAAA developing content geared toward other audiences. The sub- committee will work on drafting a social media calendar to assist in scheduling posts throughoutthe year.

• Members-Only Content

- In the August poll, 81% of respondents wanted access to a members-only platform. Since the majority of respondents are already on Facebook regularly, the sub-committee recommends expanding NYSFAAA's social media presence through the creation and moderation of a private Facebook group. The NYSFAAA members-only Facebook group will be a convenient place for current Facebook users to network, ask questions, and share industry-related content with other members. Unlike NYSFAAA's public Facebook page which is open to both members and non-members (including students, parents, and other community members), NYSFAAA's Facebook group will be private and limited to current members only. This privacy creates a highly targeted environment for increasing member engagement opportunities. It is not meant to replace other NYSFAAA communication methods and will coexist with list-serves, other socialmedia pages, and the Member Clicks community forms if/when implemented. The TICC committee will manage the rules for group members to ensure civil and respectful dialogue but will largely allow members to engage together informally and with minimal moderation of conversation. A Facebook Group can be quickly and easily archived if NYFSAAA or the TICC committee decides to end the group for any future reason.
- In conclusion, the TICC sub-committee plans to immediately increase NYSFAAA's social media

presence through a more consistent and targeted use of its existing Facebook page and the implementation of a private, members-only Facebook group. Content will be tailored with the primary goal of serving NYSFAAA members. Once Facebook is being utilized regularly and successfully, TICC will reconsider expanding to other platforms.

As co-chair of the TICC, I broke the team into two groups. Some of us are pursuing the public forums and will soon have a proposal. The group I landed in is pursuing MCCF and it is something we can launch almost overnight with EC's approval.

The idea is for people to start Discussion Groups regarding the issues of the day that concern most if not all of us.

Our team met and is making the following recommendations for launching, oversite, and promotion.

- 1. Set-up of the MCCF will be completed by Howard/Lea with assistance from MC as needed.
 - a. This can be done very quickly with approval from EC.
- 2. We decided that we would not use High Monitoring that would stop every post for approval.
 - a. High Monitoring would require every submission to be approved by an administrator.
 - b. Low Monitoring is having an administrator keep an eye on the posts and being able to delete post and remove access should content be extremely inappropriate.
 - i. A policy must be written and distributed.
 - c. In addition, we agreed that we would need multiple people to monitor the MCCF posts
 - i. Several TICC members have already volunteered
- 3. Launching can be as easy as sending an email communication advising the community as to:
 - a. What MCCF does
 - b. How to use/join/navigate
 - c. Additional, follow-up, communications would likely be needed
 - d. Set an announcement on both home pages
 - e. Committee members have a plethora of ideas of how this can be promoted. This does not have to be discussed here.
- 4. To get things started we would create conversations for people to join. Recommended conversation discussed:
 - a. Newbies
 - b. Oldies
 - c. Conference
 - d. Training
 - e. Default Management
 - f. FAFSA Simplification/New formulas
- 5. People who opt in can see their messages on the website and/or receive them in the email box of their liking.
 - a. Unlike the e-list MCCF will keep a trail of the conversation, and
 - b. Will only be involving members who opt in to the function and the conversations of their choice.

Co-Chair TICC

Howard Leslie and Sonya Stein manage NYSFAAA's social media presence and are looking at best practices for engaging social media to drive engagement. Memo will focus on a private member only, Facebook account.

Patti Donahue asked if this initiative is the same vehicle as the community forum through MemberClicks. Howard indicated that it is a different vehicle and may be in competition with MemberClicks.

Howard indicated that this is proposal is not to use high monitoring feature which requires every post to be reviewed prior to posting. This proposal would involve a low monitoring looks at words and will remove things that are deemed inappropriate.

A discussion ensued on the differences in platforms including membership requirements, privacy, rules of behavior, value in helping to drive membership, 501C (3) concerns, solicitation rules, monitoring and cost.

Facebook (FB) is equivalent to MemberClicks Community Forum (MCCF) but can FB have the same subgroups as MCCF. Per Sonya - there is not a way to have subgroups but you can have conversation threads that would be saved.

MOTION: a motion was made by Howard Leslie, seconded by Brian Smith to adopt/launch MemberClicks Community Forum as well as Facebook Social Media Platform for the Association as outlined in the submitted proposal.

The motion passed with 11 in favor, no opposition and 1 abstention.

Brian thanked Howard and Sonya for putting this proposal together.

SWT

The following information was reported by the Statewide Training Committee

- 1000+ registrants were made for the FAFSA/TAP Webinar, 950 attended. Additionally, there were 254 hits for FAFSA video.
- Verification and Taxes Part 2 had 250+ registrants and 82 hits on the video.

• The Regional meeting adjunct panel plan will need more time to organize. The panel will discuss movement back into repayment. The Committee would like to include one person from each sector to participate. Howard will volunteer for the panel for the Proprietary Sector.

Secretary's Report

Annual Report

Anne Sullivan Polino reported that the report is complete and posted to the website for membership to review. She thanked Councilmembers who provided their report sections on time.

HESC Update Simpson

Lisa Simpson reported that she and Mike Turner are scheduled to present an update on HESC Activities at the NYSFAAA Conference on October 26. The following highlights were reported to the Council. Lisa recommends attendance at the NYSFAAA session for the full update.

There are currently 2,223 opened TAP and STEM applications.

The system cannot carry four years of applications at once so 2019 is closed. 2021, 2122, 2223 are open.

TAP information is forthcoming soon

STEM applicants won't be seen until everything is complete and accepted. Private schools have lottery. SUNY and CUNY will be given the information as soon as ready. There is no lottery for these schools.

Certifications and corrections on accounts should be done earlier to avoid errors and penalizing students.

Lisa will also discuss a new platform plan at the Conference. An RFP is going out to a group that is interested in providing a system to streamline applications and processing of state aid in early 2022. HESC is putting together a focus group that includes financial aid, bursars and registrars from all sectors and financial aid processing systems.

Outreach – FAFSA completion events will be held. - one on November 4 in Region 4 for two schools in Albany area and a second session on November 18. Volunteers are needed.

A session was held on October 20 –with 125 registered and a 50% show rate. All FAFSA events are open to all schools. The group hopes to hold two or three more sessions in December through a partnership with HESC and NYSFAAA.

Renee Swift asked Lisa if there has been talk about allowing the TAP application to allow multiple schools. Lisa indicated that this would be problematic because HESC wouldn't know which school to use but agreed to bring it back to the committee for consideration. One issue is that students don't realize that they need to update the school to the final school for processing purposes. It would also likely be an issue with prepayments because all schools would get prepayment.

- Under Professional Services insurance expense is higher than in the past. A review of options found prices are up in general.

MOTION: A motion was made by Rochelle Filler, seconded by Patti Donahue to accept the Treasurer's Report as presented.

A vote was taken, and the motion passed with all in favor. .

Conference 2021 Evans/McCarthy

Jeanne McCarthy and Debbie Evans indicated that there are 390 attendees. They were hoping for 400+. Forty-nine individuals are attending for free and part of the Novice program, leaving 341 paid registrations. There are fifty-three with outstanding balances.

The conference platforms will be WHOVA and Zoom. Sean Sherwood will review these systems with Council at this meeting.

Capacity should not be an issue as the general sessions have a capacity of 1000 and 100 at breakout sessions All sessions will be recorded.

The Committee thanked Lea Nuwer for getting survey ready to go. The survey will go out on Friday with results reported at the December Executive Council meeting.

Debbie reported that the Scholarship Committee will provide 5 recipients. The Committee had trouble getting applications this year. Regional meetings should provide a mechanism for identifying this opportunity and encouragement to get students to apply. It was also reported that some individuals had an issue with the website allowing a second donation.

At this point, fund raising is dismal as compared to last year. There are 45 raffle tickets and 35 50/50 tickets. Total to date is \$1,900 compared to over \$5,000 last year. Business partners and others helped with last year's numbers.

Howard reported that there are 9 people who donated \$100 each as strictly donations.

Hopefully, next year the conference will be in person and committee will need help with gathering donations. Debbie indicated that she is stepping aside and won't be there to assist. She also reminding the group that there are still cookbooks available for sale.

Adrienne thanked Debbie for her work on the Scholarship Committee

Jeanne and Debbie also provided an update on the outstanding hotel deposit. The Hilton in Long Island is still holding the \$21,450 deposit. Debbie has made several attempts to resolve this issue only to be ignored.

Four options are available to us. .

- 1. We take no further action and lose the \$21,450 deposit.
- 2. We attempt to negotiate to use the credit for future meetings (Novice, EC, etc.)
- 3. We hire an attorney to recover the funds. Debbie's state representative provided some options for free legal advice
- 4. We engage media to bring this issue to the public's attention and the lack of empathy from Blue Sky given we've been trying to negotiate since last December when we were told it was too soon for them to

make a decision and are now indicating that it should have been done within 6 months. We did tried to get a response within that timeframe. Blue Sky indicated that the NYS Attorney General must provide a letter saying that mass gatherings are not allowed. Within two days of getting the letter the Attorney General opened up the state.

The pros and cons of using social media to help resolve this issue was discussed. Debbie will provide Adrienne with a summary of the events for continued follow up.

Sonya Stein and Stacey Hawkins, 2223 Conference Committee Chairs were told that the hotel in Lake Placid will work with them on accommodating changes because of the pandemic. It was agreed that contracts should include language on this topic going forward.

Debbie looking forward to the conference and thanks all for their help and expressed her thanks for support.

Adrienne thanked Jeanne and Debbie for being the only committee for having two conferences in a year and virtual conferences.

Debbie and Jeanne also thanked the technical people for finding the platforms and making them work and being patient and kind with training and making people comfortable with the technology.

Conference 2022 Hawkins/Stein

Stacey Hawkins and Sonya Stein provided the following update on the 2022 Conference.

The theme and logo are finalized and will be shared through a promotional video, put together by Sonya, at end of this year's conference.

Stacey also added some questions to survey about format of conference – in person or virtual, with the hope that we can make a decision soon on the format.

NYSFAAA Conference - WHOVA

Dear (Legislator title / name),

The New York State Financial Aid Administrators Association (NYSFAAA) expresses its strong support of H.R. 4631 "Protecting Our Students by Terminating Graduate Rates that Add to Debt (POST GRAD) Act". This legislation would allow graduate and first professional degree program students the ability to access Federal Direct Loan funds with more favorable borrowing terms.

Today's employment market demands many more positions be filled by individuals holding advanced graduate and first professional degrees. Students pursuing these advanced degrees have very limited funding options other than student loans. Currently, the federal student loan programs available are the Unsubsidized Direct Loans that accrue interest while the student is still attending school. This interest accrual costs individual students tens of thousands of dollars in additional interest and payments over the repayment period of the loan.

Some of the highest amount of student loan borrowing occurs in the licensed profession fields, many of which are in the greatest demand, like in healthcare. Sadly, the expense of borrowing alone can be the determining factor as to whether a student ultimately decides to pursue a profession requiring an advanced degree.

The POST GRAD Act would give students some relief by granting access to Subsidized Direct Loan funds, which would lessen the amount of interest accrued over the life of the loan. This proposed legislation is not a new concept. Prior to 2011 graduate and first professional students had access to Subsidized Federal Direct Student Loan funds with their more favorable terms. Students lost their access to these funds as part of Congressional negotiations for passage of the 2011 Budget Control Act.
